## **Terms and Conditions**

The following terms and conditions apply to all vendors, artists, and artisans who seek to participate at Freedom Fest 2009 – Christian Music Festival, August 14-16, 2009 at Country Heritage Park, Milton, ON:

1. All vendors must have applicable liability insurance coverage and licensing as required under Ontario law.

2. All sales tax is the responsibility of the vendor. Freedom Fest assumes no liability for improper sales tax.

3. Freedom Fest will provide a space of approximately 10' x 10' or as previously agreed to by Freedom Fest organizers, within Country Heritage Park for each vendor space. Exact dimensions and locations will vary depending on the number of vendors participating and the requirements of Freedom Fest and Country Heritage Park.

4. Space is provided from 9:00 am on Friday, August 14 through 4:00 pm on Sunday August 16, 2009. Vendors must be on site and in their space **no later than 11:00 am** on Friday and may not take down **before 9:00 pm on Saturday**. These restrictions are in place to avoid interfering with the performance groups. Payment of an early take down fee of \$25 is available and will indicate that the vendor chooses to leave the festival early and will accept a position at the margin of the festival to allow for an earlier take-down period.

5. Vendors may remove their tents Friday night after 9:00 pm if they choose but must have them put back up by 9:00 AM the following morning. Security is provided overnight and the facility will be secured by fence and locking gates overnight.

6. No food or beverages may be sold or given away during the Festival. Candy may be given away in moderation.

7. Vendors are responsible for maintaining their space. This includes ensuring that trash is placed in the appropriate receptacles.

8. Upon approval and receipt of payment, vendor agrees to allow publicity materials to include names, likenesses, and other materials as may be deemed appropriate for advertising, publicity or marketing of the event without compensation.

9. Free parking is provided but is NOT available at your booth. Please make the necessary arrangements for bringing your equipment into and out of the vendor area. Drop off areas will be designated within the park. Please let us know if you have specific requirements for loading and unloading.

10. This Festival is a family oriented event. Freedom Fest retains the right to remove vendors who are disruptive, violate any of these terms and conditions, or otherwise present a conflict with the stated purpose for this event.
